WHAT IS AOK9? AOK9 is oval racing for all breeds and mixes. Up to four dogs race a total of three times, called programs. Depending on the order of finish, they may attain national points towards a Racing Champion title. Singles only need to run once for a score.

There will be practice runs available between programs 1 & 2 and 2 & 3 for dogs owned by anyone willing to help at the event by being a dedicated line or foul judge for the meet. People who have entered the event and have young or non-tested dogs may also run their hounds between programs. There is no fee for the practice runs. However, this is a race meet and our desire is to get done before it gets too hot. Please limit your practices to 1 dog. If you would like more than 1 dog in practices, please check with the meet Secretary. In the event of hot weather, we reserve to postpone the practice runs until after the meet and ribbons awarded.

Sunday's ribbon ceremony will commence once the equipment has been picked up.

FROM THE NORTH

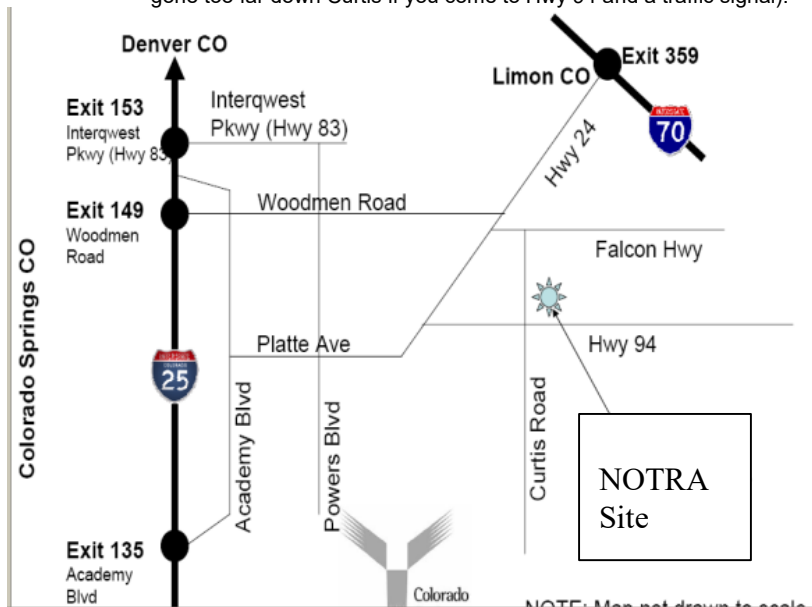
1. From I-25 South, take exit 153 Interquest Parkway/Hwy 83
2. Go on Hwy 83 to South Powers Blvd
3. Turn right on South Powers Blvd
4. Stay on Powers to Woodmen Road
5. Go left (east) ~12 miles on Woodmen to its end at Hwy 24
6. Go right on Hwy 24 1.5 miles to new Meridian interchange
7. Go left on Meridian to STOP sign at Falcon Hwy
8. Turn left onto Falcon Hwy ~3 miles to flashing yellow (Curtis Rd)
9. Turn right (south) onto Curtis Road for 4.4 miles
10. Turn left to Zoiboyz Ranch (NOTE: This will be the 2nd driveway on left after Davis Road. Ignore small house near Curtis; go up the hill to the house surrounded by white fence. You've gone too far down Curtis if you come to Hwy 94 and a traffic signal).

FROM THE SOUTH

1. From I-25 North, take exit 135 Academy Blvd
2. North on Academy 5.8 miles to East Platte Ave
3. Right on E. Platte 3.7 miles to Hwy 94 (direction Schriever AFB)
4. Right on Hwy 94 7.5 miles to Curtis Road (1st light on Hwy 94)
5. Left on Curtis Road 1.9 miles to Zoiboyz Ranch on right—house surrounded by white fence on hill. (Ignore the small house in front near Curtis Road. You've gone too far north on Curtis if you come to Falcon Hwy and blinking red traffic signal.)

FROM THE EAST

1. From I-70, take exit 359 (US Hwy 24) 54 miles to Stapleton Rd
2. Left (east) on Stapleton 1 mile and turns into Curtis Rd at Judge Orr Rd intersection to Curtis Road
3. Stay on Curtis Road 5.4 miles to Zoiboyz Ranch. (NOTE: This will be the 2nd driveway on left after Davis Road. Ignore small house near Curtis Rd, go up the hill to the house surrounded by white fence. You've gone too far down Curtis if you come to Hwy 94 and a traffic signal).

All hounds entered must be individually registered with the American Kennel Club (AKC) (eligible for entry into the Stud Book register), Canadian Kennel Club (CKC), United Kennel Club (UKC), the National Greyhound Association (NGA), or with any foreign registry recognized by the AKC. For Rare Breeds not recognized by the AKC, or by any foreign registry recognized by the AKC, hounds must be registered with the Federation Cynologique Internationale (FCI) through its affiliated registries world wide (for dogs born in the USA, the Federacion Canofila de Puerto Rico), and/or the AKC Foundation Stock Service. Hounds registered with the AKC under Indefinite Listing Privilege (ILP) or Purebred Alternative Listing (PAL), UKC Limited Privilege (LP), or the CKC equivalent Listing may also be entered for all breeds except Whippets.
